- ¹ Payments can be made in CAD, CHF, DKK, EUR, GBP, JPY, PLN, NOK, SEK, USD, ZAR.
- ² Time- later time (according to Latvian time) within banking day of Svenska Handelsbanken AB Branch operation in Latvia, by which all incoming payment orders (on outgoing payments) and payment amounts (for incoming payments) shall be considered received on the current banking day. The payment orders and payments amounts received by the Bank after the specified time shall be considered received on the next banking day. On pre-holiday days, time is shortened by 1 hour. The Bank has right to credit clients account for incoming payments amount on the next banking day in case bank needs additional inspection even payment was received with current value date until time stated.
- ³ Execution time- time until the Bank transfers funds to the beneficiary's or intermediary bank. If date is beneficiary's or intermediary bank's holiday, payment might be executed on next business day.
- ⁴ SEPA payment conditions:
- both the beneficiary's and the payer's payment service providers are incorporated in the **EEA**,
 - the beneficiary's account number is in **IBAN format** (International Bank Account Number),
 - the customer pays only Handelsbanken fee (charge option **SHA**),
 - payment execution is set to "**Standard**" or "**Express**" (settled via the real-time settlement system TARGET2). If payment is sent to the beneficiary bank that is not a member of TARGET2, the payment will be executed as Cross border Express payment in EUR.
- ⁵ **EEA** (European Economic Area) countries – Austria, Belgium, Bulgaria, Cyprus, the Czech Republic, Denmark, Estonia, Finland, France (French Guiana, Guadeloupe, Martinique, Réunion), Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, the Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden, the United Kingdom (including Gibraltar), Croatia, Jersey, Guernsey, Isle of Man.
- ⁶ Fee covered by:
- Shared (SHA)** – the price includes only the commissions of Svenska Handelsbanken AB Branch operation in Latvia, all the rest intermediary un beneficiary bank commissions connected with the payment shall be covered by the beneficiary. Svenska Handelsbanken AB Branch operation in Latvia shall send a payment to the correspondent bank or the beneficiary bank with an indication: "SHA" in the respective S.W.I.F.T. report field "Details of charges". Payments to banks in EEA in any currency are only completed if the commission fee type is SHA.
- Payer (OUR)** – the payment price indicates to the fact that all commissions arising during the payment transfer process (interbank and beneficiary bank) will be covered by the payer. Svenska Handelsbanken AB Branch operation in Latvia shall send a payment to the correspondent bank or the beneficiary bank with an indication "OUR" in the respective S.W.I.F.T. report field "Details of charges" by requesting the beneficiary bank to disburse full amount of payment to the beneficiary. The liability of Svenska Handelsbanken AB Branch operation in Latvia is limited by this provision. Svenska Handelsbanken AB Branch operation in Latvia is not liable for the fact that the intermediary bank or the beneficiary bank has not performed the instructions of Svenska Handelsbanken AB Branch operation in Latvia or if the credit transfer has not been received in full amount due to other reasons, which are beyond the will of Svenska Handelsbanken AB Branch operation in Latvia. Foreign bank fees, exceeding those of Svenska Handelsbanken AB Branch operation in Latvia, shall be added and debited from the clients account after the Handelsbanken correspondent account has been debited for the specific payment.
